5 Fire Fighting Measures

This product is only to be used by qualified dental staff.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area out of direct sunlight. Store at below 25 °C. Protect containers from physical damage. Check regularly for leaks. Keep away from strong oxidising agents.
